

# CONTEST RULES

## ARTICLE 1 – ORGANISATION

The Detox photo contest is organised by Versele-Laga, headquartered in Belgium at 9800 Deinze, Kapellestraat 70, with company number BE 0424.901.669, and Nutriquine NV, headquartered in Belgium at 9031 Drogen, Industriepark 11B, with company number BE 0861.186.883.

## ARTICLE 2 – RULES

2.1 To validly participate in the contest, the contestant must send a creative photo of his/her horse on the pasture, on a ride, etc. The photo clearly shows that the horse is relaxed, that it is feeling well. This photo is uploaded to [www.cavalorgames.com](http://www.cavalorgames.com).

2.2 After registration or login the contestant can submit their photo. The contestants know that the photo they upload can be shared on [www.cavalorgames.com](http://www.cavalorgames.com) and on Facebook (Cavalor Benelux, Cavalor, Versele-Laga).

2.3 The contest runs from 15 October 2018 up to and including 13 January 2019. This is the last day on which the photos can be uploaded.

## ARTICLE 3 – PARTICIPATION

3.1 This contest is open to any natural person.

3.2 Anyone can participate. Legal persons and staff members of the organizer, all employees of any Versele-Laga, Nutriquine or Anidis affiliate and their relatives to the second degree or resident family members may participate in the contest, but are excluded from prizes.

3.3 Children (aged under 18) must have the consent of a parent/carer or their legal guardian aged over 18 in order to participate. Winners must prove their age before they can receive their prize. The organiser may ask any winner aged under 18 to present proof of consent from parents/guardians, stating that they consent to their child taking part in the contest and to the award of the prize by the organiser. The organizer reserves the right to select another winner if the original winner cannot present sufficient proof of consent.

3.4 Participation in this contest is free.

3.5 Participating in this competition entails acceptance in full of the competition rules. The participants can find the contest rules at [www.cavalorgames.com](http://www.cavalorgames.com) or they can request them in writing from Versele-Laga and Nutriquine. In cases not covered by these rules, the organiser decides. There can be no discussion on the content of the decision.

3.6 Every Monday after one week of entries, 2 winners will be announced on Facebook. These winners each win a Cavalor fleece blanket. The winners of the

fleece blankets are chosen by the Cavalor team. The most creative, funniest photos win. Each month, the winner of the Cavalor Detox package will be announced on Facebook. This package is raffled off. The prizes are sent directly to the winners' addresses. The winner is the actual owner of the mailbox which was used to participate in the competition.

#### ARTICLE 4 – PRIZES

4.1 During the course of the contest, 2 Cavalor fleece blankets are given away weekly. 1 participant will win a voucher for a Cavalor Detox package per month; this entails 11 bags Cavalor FiberForce, 1 Cavalor Vitaflor 365 and 1 Cavalor Hepato Liq.

The personal data are only kept for the duration and for the benefit of the Contest and will not be used for commercial purposes.

These data will not be sold or transferred to third parties in any way whatsoever.

#### ARTICLE 7 – COMPLAINTS

7.1 Any complaint must be filed by registered letter including a reasoned argument to Versele-Laga before 1 February 2019: 9800 Deinze, Kapellestraat 70.

7.2 Versele-Laga's decision is final; no legal recourse is permitted.

#### ARTICLE 8 – LIABILITY

8.1 The organization cannot be held responsible for any technical problems during the uploading of the photos. In addition, the initiators cannot be held responsible for any damage experienced by the participants, such as problems related to computer networks, computer virus infections and unauthorised computer access.

8.2 If one or more regulations of these terms should be legally invalid in whole or in part, than won't this affect the validity of the other rules. Each invalid regulation will be replaced by a similar rule which will meet as close as possible the intended goal of the invalid regulation.

8.3 The organiser cannot be held responsible for interruption or cancellation of the contest for causes outside his control.
